

Taking into account the guidance provided in EASA letter No JAN/kgu/R(4) 2013(D)51397 dated 29 April 2013, the Uzbekistan Civil Aviation Agency informs that the application of PRACTICE 3, as indicated in the above mentioned EASA letter, will constitute the proper way to release the aircraft registered in Uzbekistan by the concerned organisations.

The EASA Part 145 organisations should perform and release the maintenance following the Uzbekistan national aviation legislation but they still can refer to EASA approval number. Such maintenance release should enclose the following statement:

"Certifies that the work specified, except as otherwise specified, was carried out in accordance with Part-145 under the Civil Aviation Agency under the Ministry of Transport of the Republic of Uzbekistan and in recognition of the organisation's EASA Part-145 approval, and in respect to that work the aircraft is considered ready for release to service".
