Revision 1 to letter № -05-04/2770 dated 29.06.2023

**On acceptable CRS statement**

In accordance with the Item 64 of the Certification requirements for the maintenance and repair of aviation equipment, approved by order of Acting Minister for Investments and Development of the Republic of Kazakhstan dated February 24, 2015 No. 196 and Item 46 of the Certification requirements for civil aircraft air operators, approved by order of Acting Minister for Investments and Development of the Republic of Kazakhstan dated February 24, 2015 No. 153, it is required to issue the certificate of release to service (CRS) which shall be completed and signed to certify that the maintenance work performed has been completed satisfactorily and in accordance with approved data and the procedure described in the maintenance organization's procedures manual.

To demonstrate means of compliance with the requirements referenced above, the acceptable certificate of release to service should contain the appropriate statement below. Reference should also be made to the maintenance organisation's approval number and the identity of the person who issued the release. The appropriate documentation such as organisation's manuals, expositions, and aircraft technical logbook pages should be amended within next 6 months from the date of initial letter dated 29.06.2023.

If you choose alternative certificate of release to service statement to comply with the requirements referenced above, please notify the Aviation Administration of Kazakhstan within next 30 calendar days for consideration and acceptance.

**For Maintenance organisations certified by the AAK**

*Certifies that the work specified, except as otherwise specified, was carried out in accordance with the Article 48 of the Law 339-IV of the Republic of Kazakhstan and in respect to that work the aircraft is considered ready for release to service.*

**Applicability:** This letter applies to aircraft registered in the State register of civil aircraft of the Republic of Kazakhstan or aircraft operated under the ICAO Article 83 bis agreement signed between the Irish Aviation Authority and AAK, according to which the aircraft State of Registry (Irish Aviation Authority) has transferred surveillance responsibilities for maintenance to State of Operator (AAK).

In addition, please be advised that an amendment to the relevant regulatory legal acts is planned to add the statement of the release to service.
